• A Free or Reduced Lunch eligibility letter from the student's school

**Families should expect to pay a minimum of \$50 in tuition per student** per year to participate in MYS (in addition to \$40 registration fee). Applicants will be notified by email of financial aid awards as funds permit. There are no late fees assessed for applicants. **Please fill out a separate Financial Aid Application for each child**, however, you only need to submit one set of tax returns **OR** one Free or Reduced Lunch eligibility letter from the student's school for the family.
